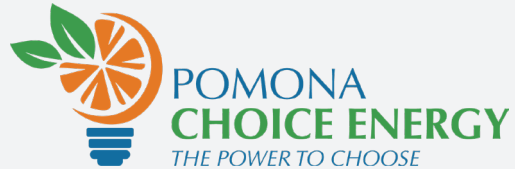




# CURRENT Options

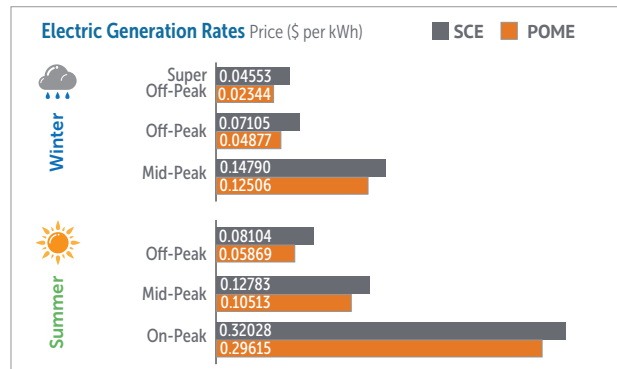

\*This comparison illustrates the estimated electricity costs for a typical Schedule TOU-GS-1-E commercial customer within the City of Pomona with an average monthly consumption of 933 kilowatt-hours (kWh). This is based on SCE's 2020 static load profiles within SCE's service territory and SCE's published rates as of February 1, 2021 and POME's published rates as of October 1, 2020.

**Generation Rate** reflects the cost of producing or purchasing electricity to power your business. This rate will vary depending on your service provider and rate plan.

**SCE Delivery Rate** is a charge assessed by SCE to deliver electricity to your business. This rate depends on usage.

**Surcharges** represents the Cost Responsibility Surcharge (CRS) and Franchise Fee (FF) that are applicable to Community Choice Aggregation (CCA) customers and SCE customers that elect a Green Rate. The CRS is a surcharge to recover costs associated with power purchases made on behalf of customers prior to a customer's switch to a CCA or SCE Green Rate. The FF recovers taxes owed to a city in exchange for allowing SCE to utilize electrical distribution lines throughout the property of the city. SCE acts as the collection agency for the FF surcharge which is levied by cities and counties for all customers.
